a.	<input checked="" type="checkbox"/>	To discuss the reputation, character, physical condition or mental health rather than the professional competence of an individual, or to discuss the discipline of, or complaints or charges brought against, a public officer, employee, staff member or individual.
b.	<input checked="" type="checkbox"/>	To conduct strategy sessions in preparation for negotiations with nonunion personnel, or to conduct collective bargaining session or contract negotiations with nonunion personnel Units B, C, D, E, F, H
c.	<input type="checkbox"/>	To discuss strategy with respect to collective bargaining or litigation if an open meeting may have a detrimental effect on the bargaining or litigation position of the governmental body, and the chair so declares; the chair should declare that an executive session is necessary to protect the bargaining or litigation position of the body.
d.	<input type="checkbox"/>	To discuss the deployment of security personnel or devices, or strategies with respect thereto.
e.	<input type="checkbox"/>	To investigate charges of criminal misconduct or to discuss the filing of criminal complaints.

i.	<input type="checkbox"/>	To meet or confer with a mediator, as defined in section 23C of MGL CH 239, with regard to any litigation or decision on any public business within its jurisdiction involving another party, group or body, provided that: (a) Any decision to participate in mediation issues shall be made in open session and the parties involved and purpose of the mediation shall be disclosed; and (b) No action shall be taken by any governmental body with respect to those issues which are the subject of the mediation without deliberations and approval for such action at an open meeting after such notice as may be required by this section.
j.	<input type="checkbox"/>	To discuss trade secrets or confidential, competitively-sensitive or other proprietary information provided in the course of activities conducted by a governmental body as an energy supplier under a license granted by the department of public utilities pursuant to section 1F of chapter 164, in the course of activities conducted as a municipal aggregator under section 134 of section 136 of said chapter 164, when such governmental body, municipal aggregator or cooperative determines that such disclosure will adversely affect its ability to conduct business in relation to other entities making, selling or distributing electric power and energy.
